- A. An official bank statement for a **Savings** or **Checking** account in your name. Bank statements must clearly show the account holder's name and must be dated within 6 months. We do not consider investment or retirement accounts. If the bank statement is not in English, a certified English translation must be attached to the original.
- B. If you will be supported by a **private sponsor** (family member, friend, or private institution), the sponsor must sign page 1 of this document (Financial Sponsor Information) and the bank statement must clearly show the account holder's name and must be dated within 6 months. We do not consider investment or retirement accounts. If the bank statement is not in English, a certified English translation must be attached to the original.
- C. Letter of financial support or financial guarantee document from government sponsors or foreign embassies which specify Gavilan College as the student's school and the validity period of financial support
- D. An official scholarship award letter addressed to you and specifying the amount and validity period of financial support.
