Selective Service Failure to Register

Status Information Letter Guidelines

Federal regulations require men aged 18 through 25 to register with Selective Service system. This requirement covers men residing in the United States who are U.S. citizens or noncitizens, except a man who is in the U.S. as a lawful nonimmigrant isn't required to register as along as he maintains that status.

If the student does not meet any of the exemptions listed on page 1 and failed to register for Selective Service, the student will need to request an official response from the Selective Service indicating if you were or were not required to register. a "Status Information Letter" from the Selective Service. After you receive the "Status Information Letter," please submit a copy of the Financial Aid Office along with this form.

How to request an official Selective Service response saying you were or were not required to register.

BY PHONE

Call the Selective Service at 1-847-688-6888. Your call will be answered by an
automated voice processing system. Please refrain from pressing any numbers, and an
operator will soon come on the line to assist you. Request a "Status Information Letter."

Visit the website: www.sss.gov. Refer to the menu on the left, and click on "Registration Information." Scroll down and click on "Men Over the Age of Eligibility to Register." Scroll down and click on "Request for Status Information Letter." You will need to print this PDF document. Please complete it and mail it the address on the form.

Final Decision

The Financial Aid Office, not the Selective Service, will determine whether you have shown that your failure to register was not a knowing and willful failure to register. The final decision regarding your eligibility for the benefit that you seek will be made by Financial Aid Office.
