Selective Service Failure to Register Exemption Guidelines and Certification

Federal regulations require men aged 18 through 25 to register with Selective Service system. This requirement covers men residing in the United States who are U.S. citizens or noncitizens, except a man who is in the U.S. as a lawful nonimmigrant isn't required to register as long as he maintains that status.

Exemptions:

Men exempted from the requirement to register include:

- _____ Males currently in the armed forces and on active duty (this exemption does not apply to members of the Reserve and National Guard who are not on active duty. **Documentation:** Copy of DD-214.

- _____ Males who are not yet 18 at the time they complete their applications (an update is not required during the year, even if a student turns 18 after completing the application). **Documentation:** ISIR with date of signature and confirmation of student's date of birth.

- _____ Males born before 1960: **Documentation:** ISIR with date of birth confirmation.

- _____ Citizens of the Republic of Palau, the Republic of the Marshall Islands, or the Federated States of Micronesia. **Documentation:** proof of citizenship from specified country.

- _____ Noncitizens who first entered the U.S. after they turned 26. **Documentation:** Entry documentation like I-94, 1-151, or Home country passport which documents entry to U.S. when he was past age of 25.

- _____ Noncitizens who entered the U.S. as lawful nonimmigrants on a valid visa and remained in the U.S. on the terms of that visa until after they turned 26. **Documentation:** Copy of valid visa

Students who were not required to register prior to meeting one of these criteria and who were unable to register due

- _____ Hospitalization, incarceration, or institutionalization through the age of 25. **Documentation:** Release papers from hospital or jail.

- _____ Enrollment, through the age of 25, in any officer procurement program at The Citadel, North Georgia College and State University, Norwich University, Virginia Military Institute, Texas A&M University, or Virginia Polytechnic and State University. **Documentation:** Enrollment confirmation.

- _____ Through the age of 25 was commissioned Public Health Service officer on active duty or member of the Reserve of Public Health Service on specified active duty. **Documentation:** DD-214
