### **Residency and Tuition**

The Education Code defines California residency for the purpose of establishing resident tuition at public postsecondary institutions as a “student who has residence in the state for more than one year immediately preceding the residence determination date.” (Ed. Code, § 68017.) This residency determination is important because nonresidents are subject to an additional fee. (Ed. Code, §§ 68050 et seq., 76140, 76141.) Education Code section 68050 generally requires that students who are not residents of California pay nonresident tuition in addition to fees required by the institution of resident students.
