Your 2019-20 California Dream Act (CA-Dream) was selected for review in a process called verification. The law says that before awarding State Student Aid, we must ask you to confirm the information you reported on your Dream Act application. To verify that you provided correct information, the Financial Aid Office will compare your Dream Act with the information on this worksheet and with any other required documents. If there are differences, your information may need to be corrected. You must complete and sign this worksheet, attach any required documents, and submit the forms to Gavilan.

There are 3 ways to obtain your 2017 IRS Tax Transcript*

1. Call 1-800-908-9946. Be sure to request Tax Return Transcript, not an account transcript.
2. Go to www.irs.gov and click on "Order a Return or Account Transcript" link to order a Tax Return Transcript.
3. Go to www.irs.gov and click on "Get Transcripts for My Tax Records" link to download a Tax Return Transcript. This option is temporarily unavailable, but will be restored in the future.

Be aware that option 1 & 2 can take up to 10 business days for delivery of transcript via mail.

*You will need the Social Security Number, date of birth, and address on file with the IRS (normally this will be the address used when the 2017 IRS tax transcript was filed). It takes up to 2 weeks for the IRS income information to be available for electronic tax return filers, and up to 8 weeks for paper IRS tax Return filers.

4. Certification and Signatures

Each person signing this worksheet certifies that all of the information reported on it is complete and correct. The student and one parent must sign and date.
