With the support of the YMCA of Silicon Valley, Gavilan College will renovate the CDC building and establish a childcare center. This center will open in the fall of 2026 and provide much-needed childcare services for our students and staff.

We have requested the same resources for the past 8 years.

The YMCA of Silicon Valley has received a **\$1,749,800 grant** from the County of Santa Clara through the Valley Health Foundation, made possible by the County's Childcare Expansion Grant Program. The grant will support the renovation of the Gavilan College Child Development Center and the launch of the Early Learning Center. The County is funding the program utilizing American Rescue Plan Act funds, and the Valley Health Foundation administers the grant.

Materials are needed for students to complete what is required/expected to meet student leaning outcomes. The funding would provide the CDES program with materials that can be used by students and teachers while they complete expected assignments and projects during their practicum hours.

Currently, these funds are provided via VTEA with exception of funding for student fingerprinting..

Next year we may be running into issues of fingerprinting costs due to having our lab experience in community agencies. In the past we used SWP funds for this purpose but we no longer have access

to those funds. We have approximately 10 students in the community agencies for student teaching. We have suspended observations which are important for CDPsyc2,3, 40 and CD1,. We still have observation requirements for CD4 and CD32 courses. This year we couldn't do observations since we didn't have the funds for fingerprinting students in CD32. There are usually 10-12 students needing fingerprints. This challenges the basic effective practice of developing curriculum based on the needs of children via observations. We used videos and students have not been as successful.

Students for CD30A & CD30B are placed in the community with mentor teachers to complete their practicum hours (required for A.A. and transfer). Mentor teacher must meet qualifications through the State, support students in the classroom, and meet with the practicum instructor monthly. CDES is dependent on Mentor Teachers for the courses to remain active. Mentor Teachers must be paid to further support the students educational goals.

Child care is considered a basic need for students by the Chancellor's Office. Student teachers need more options if there are not enough child development agencies to meet the needs to complete practicum. Our

communities need more care for their children, especially for infants and toddlers. Students struggle to complete the required 108 hours. Therefore, completing hours during their breaks.
