- 8.1 \$2 Student Representation Fee (2SRF), David DiDenti, Region IV Representative (15 min)

*The student representation fee is a fee collected from enrolled students to be used by the discretion of the Associated Student Organization on campus. A new bill has been introduced to increase that fee from \$1 to \$2. That second dollar would go to the SSCCC to conduct business and advocate for students at the region and state level. Initially SSCCC would get their money from the Chancellors Office which presented a “biting the hand that feeds you” dilemma. With SSCCC being an autonomous and self-funded organization then they would be better positioned to advocate even when they disagree with the Chancellors Office or other state offices. It was suggested that ASGC members think about when to begin to pursue this venture.*
