Guided Pathways FIG is working on developing pathways that would allow students to graduate faster by offering classes in a more impactful sequence. The FIG is looking for more student input. Look out for more upcoming meetings.
- 8.2** Spring 2017 Graduation Day, Blanca Arteaga, ASGC Advisor (15 min)
Graduation Committee is meeting today from 1 to 2 pm in BU118. In the past ASGC has held a reception after graduation for students and their families. After initial conversations with students it was determined that students are not very inclined to attend the reception. It was suggested that the reception be held before graduation in front of the Theater. For the reception ASGC would have to decorate the area of the event, running the event, and cleaning up after the end. Received a quote from Pacific Dining, for 350 people, that include 6 food items per person keeping in consideration food items that are not too messy. The total would be \$2337 for the full service. It was suggested that we look for food outside of Pacific Dining. An estimated \$1190 would be spent for 300 people if ASGC is willing to do the work.
