7.2 Region IV Representative

Region meeting last Friday where the resolutions were discussed. Region IV is pushing for the \$2 Student Representation Fee (SRF). This is something that the incoming ASGC President and Student Trustee will be hearing about next semester. We already have a \$1 SRF that goes to ASGC to fund our events. The second dollar goes to SSCCC to fund them, because they are currently funded by the chancellor's office and there is a conflict of interest. We were supportive of this to begin with, but it was later revealed that SSCCC is not recognizing the non-voting members despite their contribution. Dave went to the silicon valley leadership group the weekend before. This is a group together to work with an organization to tackle certain issues. They're looking for issues in the community and see how students can work toward fixing those problems. Next meeting is tentative, but they will want continuous membership. As long as Dave is still here, he will go, but we will need other student leaders to be involved in the future.
