8.0 Discussion Items

- 8.1** Resolution Packet for General Assembly, Adam Lopez, President (25 min)
Group consensus on the ambiguity presented in these resolutions. Free speech resolution inserted to reserve the institutional right to protect free speech, not necessarily that it was threatened to begin with. Resolutions are not necessarily policies that our school needs to adhere to, but strong suggestions. Tanie provides us a brief explanation of net neutrality as it applies to measure F17-A-04 on Net Neutrality. Leslie brought up the idea of student-wide training educating students on hate speech. Potential idea of including education on hate speech within our kickstart orientation. Nolan commented on his disappointment in the premise of F17-A-02-01, which states that Students have difficulties finding offices and facilities, and that we'd need an interactive map to be aware of the location of services on our campus. Nolan expressed the need to define a microaggression in measure F12-R-02-01.
- 8.2** Updated bulletin board layout, Adam Lopez, President (5 min)
Adam's computer crashed, so we aren't able to see his layout. Updated posting policies are not posted online. Bulletin board ambiguity yet to be addressed throughout campus.
